Advance Care Planning	1123F	Advance Care Planning discussed and documented advance care plan or surrogate decision maker documented in the medical record
Advance Care Planning	1124F	Advance Care Planning discussed and documented in the medical record, patient did not wish or was not able to name a surrogate decision maker or provide an advance care plan
Advance Care Planning	1158F	Advance care planning discussion documented in the medical record
Controlling Blood Pressure - Diastolic 80-89	3079F	Most recent diastolic blood pressure 80-89 mm Hg
Controlling Blood Pressure - Diastolic Greater Than or Equal to 90	3080F	Most recent diastolic blood pressure greater than or equal to 90 mm Hg
Controlling Blood Pressure - Diastolic Less Than 80	3078F	Most recent diastolic blood pressure less than 80 mm Hg
